## ANDHRA PRADESH LEGISLATURE BULLETIN

The Members of Andhra Pradesh Legislative Assembly are informed that the Thirtieth Session of Andhra Pradesh Legislative Council and Eleventh Session of XIV Andhra Pradesh Legislative Assembly are scheduled to commence at 09.30 A.M. on 05-03-2018, at Velagapudi, Amaravathi, Guntur District. The Hon'ble Chairman and Hon'ble Speaker have issued the following directions for smooth functioning of A.P. Legislature.

All the Ministers and Members are requested to co-operate by adhering to the following directions of the Hon'ble Speaker.

## I. Entry into the precincts

- 1. Hon'ble Chairman, Hon'ble Speaker, Hon'ble Deputy Chairman, Hon'ble Deputy Speaker and Hon'ble Chief Minister may enter the precincts through Gate No. I.
  - (a) Ministers, Leaders of Opposition, Deputy CMs, Govt. Chief Whips, Govt. Whips will enter through Gate II.
  - (b) MLCs and MLAs will enter the premises and alight at Gate No. IV.
- 2. No other person is permitted in the vehicles of Ministers/ Members while entering the Legislature Complex.
- 3. Car Passes issued for the present Session should be displayed prominently on the front wind screen of the vehicle to avoid any inconvenience.
- 4. All vehicles would be halted for Security check at Gate IV. Members are requested to cooperate with the Security personnel and Vehicles will be parked in parking area in front of Gate No. IV.
- 5. All Vehicles have to be parked at the designated places in the parking area opposite Gate No.IV.
- 6. Vehicles of Hon'ble Deputy Chairman, Hon'ble Deputy Speaker, Deputy Chief Minister, Ministers, Govt. Chief Whips, Govt. Whips and Leader of Opposition will have to be parked in the precincts of the Assembly near Gate No. II.
- 7. Vehicles driven by Members themselves also have to be parked in the parking place. Chauffer driven vehicles of Members will be allowed to enter through Gate—IV and those vehicles shall have to be parked in parking area opposite to Gate No.IV after dropping the Members.
- 8. Strangers would not be permitted to enter into the Assembly premises.
- 9. Personal Security personnel would not be allowed beyond the **Gunmen Point** located opposite to Gate No.IV.
- 10. Vehicles without valid pass will not be permitted in the parking area.
- 11. Entry to the Speaker's, Chief Minister's Corridor is Strictly Prohibited.
- 12. Visitors are allowed with clear indication of time so as to facilitate more Visitors.
- 13. Visitors and other Staff of Government Departments will not be permitted to move except to Visitors Gallery and Ministers Chambers through the Entry Point. IX (Stair Case) at South East corner of the building.

## II. Carrying of Objects and Material Strictly Prohibited

- 1. MEMBERS SHALL NOT BRING WEAPONS OF ANY KIND INTO THE ASSEMBLY HALL. They are requested to deposit them at the "Bell of Arms" provided near the Members Service Counter i.e., Room No. 121 on the ground floor before entering into the House.
- 2. Carrying of Fire arms, Banners, Lathis, Spears, Swords, Sticks, Brick Bats, Placards, etc., is strictly prohibited.
- 3. Members shall not shout slogans; distribute pamphlets, leaflets and any other material in the precincts of the House.
- 4. Meetings, Processions, Demonstrations, Picketing or Dharna or sitting at any place <u>within the precincts</u> of Assembly is strictly prohibited.
- 5. Members are requested not to indulge in any activity which may cause or tend to cause inconvenience to other Members.

## III. Press conferences

- 1. Media Point is earmarked in between Gate No.III & IV for holding press conferences and interviews by the Hon'ble Ministers & Members during the Session days.
- 2. Press conferences other than that of the Ministers and Members shall not be permitted within the precincts of the Legislature.
